TERMS:

Gasoline and Fuel Oil purchases (3,500 gallons or more) up to the approved credit limit are due and payable via **Electronic Funds Transfer** **NET 9 calender days** after delivery of product. *Purchase amounts which would exceed the approved credit limit, will be required to be paid immediately.*

Bulk oil, packaged goods, auto accessories, and gasoline and fuel (less than 3,500 gallons) are due and payable **NET 30 calendar days** after delivery of product. *Purchase amounts which would exceed the approved credit limit, will be required to be paid immediately.*

It is also understood and agreed to, that as a charge customer, all purchases must be paid in full within the specified terms of sale, and that a finance charge of one and one half percent (1 1/2%) per month, which is an annual percentage rate of eighteen percent (18%), will be applied to any past due billings. Date of payment is the date received by Lyden Oil Company. If the account becomes more than 60 days delinquent and is placed in the hands of a collection agent or attorney, Customer will pay reasonable collection charges incurred, including attorney fees.

All orders are subject to credit approval by *Lyden Oil Company's* Credit Department prior to acceptance of the order. Orders may be refused and delivery may be withheld on accepted orders without liability on *Lyden Oil Company's* part, if in its sole opinion, the customer has not demonstrated sufficient financial ability to pay for the product on the terms and conditions of sale.

Lyden Oil Company will charge the following taxes to the applicable purchases unless provided with the proper exemption documentation.

- State sales tax

- Federal gasoline / fuel tax
- State franchise tax (in states where applicable)
